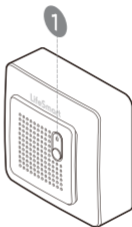
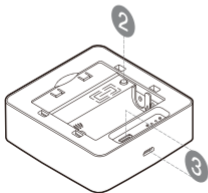

- ① After configuration of the Smart Station, choose "**Add Device**" in LifeSmart App, select "**Environmental Sensor (CO2)**" to enter pairing process.
- ② Follow the instruction on the app to finish pairing.
- ③ If a time-out error occurs, please repeat step 1-3 until it's successfully paired.

This product needs to keep the power connected, please make sure that both ends of the cable plug are connected to the product and the socket respectively. This product requires a period of time to accumulate data after initial startup, please be patient and wait for it to return to normal working condition.
